1. GRANTEE: Honeywell International, Inc.
Morristown, NJ
2. PURPOSE AND LIMITATION:
 - a. This exemption authorizes the transportation in commerce of small quantities of the materials listed in paragraph 6, in inner packages without cushioning or absorbent material around the inner packages, as not subject to the Hazardous Materials Regulations (HMR) when transported by highway or cargo aircraft and packaged in accordance with § 173.4 and this exemption. This exemption provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
 - b. The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 172.301(c) in that marking the exemption number on the package is waived; § 173.4(a)(4) in that no cushioning or absorbent material is required to surround the inside packaging; and § 173.4(a)(10) in that the outside of each package is not marked with the certification statement.
5. BASIS: This exemption is based on the application of Honeywell International, Inc., dated October 18, 2002 submitted in accordance with § 107.105 and the public proceeding thereon and additional information dated November 18, 2002.

6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES:

a. PACKAGING - Inner packagings prescribed are sensing elements that are hermetically sealed copper metal capsules approximately 2 to 4 inches in length and from 0.375 to 0.50 inches in width. The capsules contain very small quantities (approximately 11 mL to 20 mL) of the materials listed in paragraph 6 above, and comply with the descriptions and drawings in Honeywell International's application on file with the Office of Hazardous Materials Exemptions and Approvals.

b. The capsules are contained in plastic bins which hold between 100 and 200 capsules.

8. SPECIAL PROVISIONS:

a. A person who is not a holder of this exemption who receives a package covered by this exemption may reoffer it for transportation provided no modification or change is made to the package or its contents and it is reoffered for transportation in conformance with this exemption and the HMR.

b. A current copy of this exemption must be maintained at each facility where the package is offered or reoffered for transportation.

c. When transported by motor vehicle, carriage may be by contract or common carrier.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle and cargo aircraft only.
10. MODAL REQUIREMENTS: A current copy of this exemption must be carried aboard each aircraft or motor vehicle used to transport packages covered by this exemption. The shipper must furnish a copy of this exemption to the air carrier before or at the time the shipment is tendered.
11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:
 - o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this exemption, including display of its number, when this exemption has expired or is otherwise no longer in effect.

12. REPORTING REQUIREMENTS: The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (Sections 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incident involving the package and shipments made under the terms of this exemption.
